TDPUD Residential Energy Rebates

GENERAL PROGRAM RULES AND REQUIREMENTS

- Only TDPUD electric customers may qualify for these rebates.
- Attach dated sales receipt with energy efficient equipment or service clearly identified.
- Provide proof of energy efficiency where required (test results for building efficiency, U-value and SHGC for windows)*
- Rebate application must be received within 90 days of purchase or service invoice.
- New construction projects are not eligible.
- One energy rebate per equipment type or service per TDPUD account.
- Rebate not to exceed the cost of equipment or service.
- Customer agrees to allow verification of make/model, efficiency & installation by an authorized District representative if requested.

REBATE DESCRIPTIONS & REQUIREMENTS

Energy Efficient Lighting (Light Bulb)

Qualifying energy efficient CFLs or LEDs receive a rebate of up to \$5 per bulb.

Bulb Type	Minimum Purchase	Incentive per bulb
Compact Fluorescent (CFL)	5 bulbs	\$2
Non-Energy Star Light Emitting Diode (LED)	5 bulbs	\$2
Energy Star Light Emitting Diode (LED)	2 bulbs	\$5



- Rebate limited to 25 bulbs (CFL and LED)
- Rebate not to exceed total bulb purchase price
- **Bulbs must meet Energy Star specifications to qualify for \$5/bulb rebate**
- Only screw in, GU10 or GU5.3 base bulbs qualify
- Rebate on light bulbs only, fixtures do not qualify

Building Efficiency

Test and repair your building envelope or duct system to save energy and received a rebate.

	Rebate
Building Envelope Air Leakage Test (Blower Door Test)	\$75/building
Building Envelope Air Leakage Mitigation	Up to 50% cost ; \$250 max
Central Air Distribution Leakage Test (Duct Test)	\$75/building
Central Air Distribution Leakage Mitigation (Duct Repair)	Up to 50% cost; \$250 max

*Testing before and after mitigation is required to qualify for either Mitigation rebate.
Mitigation invoice must detail measures installed and/or work completed.

Thermally Efficient Window***

TDPUD pays \$5 per square foot of window to replace single-pane windows or dual-pane windows over 20 years old with qualifying windows.

- Primary heating source must be a permanent electric space heating system
- Existing window must be single or dual pane over 20 years old
- Windows must meet Energy Star specifications for Northern-Central Climate zone or equivalent*
 - U-factor ≤ 0.30 and Solar Heat Gain Coefficient ≤ 0.40
 - See EnergyStar.gov for additional specifications
- Provide proof of decommissioning of single pane windows (photos or receipt from landfill)

Ground Source Heat Pump (GSHP)

GSHPs (also known as geothermal heat pumps) use the earth's natural heat to provide heating, cooling, and often, water heating. TDPUD offers a rebate of \$200 per ton. Contact the program administrator for additional details. 530.582.3963
