Beginning April 2013 the improved TDPUD Appliance Rebate Program encourages customers to purchase energy efficient appliances by providing increasing incentives for more efficient appliances as identified by Energy Star and the Consortium of Energy Efficiency (CEE). Appliances listed as Energy Star only and/or CEE Tier 1 may qualify for a \$75 rebate. CEE Tiers 2 & 3 identify super-efficient appliances that use significantly less energy than the federal standard and identify the most energy efficient of the Energy Star spectrum. CEE Tier 2 & 3 listed appliances may qualify for rebates as noted on the application.

## How can I determine if an appliance is an Energy Star appliance?

1. Look for the Energy Star logo on the Energy Guide or the product literature.
