ADDITIONAL AGENT AUTHORIZATION AGREEMENT

This Additional Agent Authorization agreement permits Truckee Donner Public Utility District (TDPUD) account holders who are property owners to delegate certain rights to third parties who are agents for the property owner. These rights are for the purpose of managing the property owner's TDPUD account(s). A TDPUD customer who is a property owner may permit their agent, such as an employee, to receive information or transact business with TDPUD on their behalf. The customer must specify the information the third party is entitled to receive and whether the third party may transact on their behalf. The TDPUD customer who is a property owner may revoke or modify the authorization of his or her agent for said property at any time by submitting a written request to TDPUD.
