Electric AMI Meter Opt-Out Program

The Truckee Donner Public Utility District (TDPUD) provides its customers a choice to opt-out of their electric AMI meter installation. The Opt-Out Program is limited to residential customers only. Customers who rent shall obtain written property owner approval to participate. Net-metering accounts and seasonal rentals or leases are specifically excluded from the Opt-Out Program.

The program allows customers to have their meter read manually once a month. If you choose to opt out, the following charges will apply:

Meter Opt-Out Fees

Setup and Exit Fee: \$158 (One-time fee)

Meter Reading Fee: \$30 (Monthly charge added to bill)

Customers can enroll in the Opt-Out Program at any time during the year. Once enrolled, they will continue to be enrolled unless one of the following occurs: the customer requests to exit the Opt-Out Program; District personnel are unable to read the meter twice in any 12 month period (due to snow/ice accumulations, locked gates, fences, dogs, other obstructions or impediments to access or personnel safety); change in home ownership; or the customer-renter vacates the property. When any of these events occur, the customer will exit the Opt-Out Program and an AMI meter will be installed at the expense of the District.

If you elect to opt-out of the electric AMI meter installation, please complete both Section A and Section B below. A customer's election to opt-out of the Electric AMI Meter Opt-Out Program is **not** effective unless this form is completed in full.
